## Terms & Conditions

### Legal Stuff

All guests that appear to be under the age of 18 will be asked for a photo ID. Please ensure guests that may be required, are informed to bring photo I.D if they wish to be served and save any embarrassment on the day. Please do not attempt to buy alcohol for under 18's - It is an offence to buy alcohol for a person under the age of 18. It is an offence for us to supply alcohol to an adult if we believe it will be supplied to a person under the age of 18. The client is responsible for the behaviour and conduct of its guests. Should any staff find themselves being abused throughout the event, Rum-n-Gin Bar will cease to operate, and the police will be called/informed.

Your venue, regardless of where it is held, will require a licence. If the venue has no licence, we can if required, apply for one on your behalf. Once the venue is licenced, the same rules apply, that apply to any pub or club, as with all licenced premises the Rum-n-Gin bar operates under The Licensing Act 2003 and we operate a "think 21" policy; If your premises already has a licence then we will need to see if prior to the event taking place. One other responsibility we need to adhere to is that guests purchase their drinks from the bar we have provided for you. Guests bringing their own drinks to the party (alcoholic or non alcoholic) are not allowed due to licensing conditions. We are more than happy for you to provide your own table wine, welcome drinks and toast drinks. Any other drinks not provided by the bar are strictly prohibited unless otherwise agreed beforehand.

### Deposits & Cancellations

A minimum deposit of £50 to be paid on booking, this secures your booking. The booking fee is from £300.00, this is dependent on number of guests and location.

The balance is due 90 days prior to the event taking place. You can of course pay in full when booking. If you require us to travel more than 30 miles for your event there will be an additional fee of £1.50 per mile (dependant upon location) This will be discussed and agreed upon prior to the booking being finalised and signed by the client.

If full payment is not received before the 90 days prior to the event, we will be unable to provide our services and any deposits pre-paid will be non-refundable. Should you wish to cancel your booking 90 days notice is required for a full refund of your deposit or booking fee.

Any cancellation under 90 days of your event will result in the deposit or booking fee being lost - (non refundable). If a licence for your event has already been applied for, the cost of this will be deducted from your deposit or booking fee if/ when returned.

Until your booking form is completed and returned and your deposit is paid we reserve the right to cancel at our discretion. Rum-n-Gin Bar accepts no liability for any failure to provide our services which is a circumstance beyond our control, for example, extreme weather conditions, vehicle road traffic collision/breakdown, electricity failure, or an "act of god"

All clients are responsible for their guests actions, where a guest damages any of the Rum-n-Gin Bar, or any additional items that are a part of the bar set up, or the vehicle that pulls the bar, you the client will be held responsible for repairing and or replacing the item as the manufacturer sees fit. Rum-n-Gin bar will dispose of all waste created by them, we will not be held responsible for removing other waste not created by them from the event.
